5. ADOPT MINUTES OF MARCH 1, 2018

6. PESD BOND ANNUAL AUDIT REPORT

Francine Story, CBO apologized for the delay in presenting the annual audit report to the committee, she explained the bond audit is a requirement. Francine summarized pages from the audit with detail information and informed the committee how to read and understand the audit report. She shared she was pleased to inform the committee no finding were found and the District is in compliance with the revenue and expenditure requirements.

7. DISCUSSION AND ACTION OF SELECTION OF OFFICER(S)

Francine Story informed the committee the appointment of Mr. Dave Santos as a Governing Board Member created a vacancy for chairman to the COC. She also shared that Mr. Jose Marin apologized for not being able to attend the meeting, but shared an interest in being elected chairman.
